You will gain knowledge and understanding of:


- pregnancy, childbirth and parenting;
- how to care for newborn babies;
- how to meet the needs of small children (aged 0-5 years) for example dietary, health and educational considerations; and
- the social, physical, intellectual, communication and emotional development of small children.

You will be able to demonstrate your knowledge and understanding in the examinations and the investigation task.



#### **WHAT WILL I STUDY?**

UNIT ASSESSMENT	AREAS OF STUDY
Unit 1: Parenthood, Pregnancy and the Newborn Baby	You will study:  • the family and parenting responsibilities;  • reproduction;  • pregnancy;  • diet and lifestyle during pregnancy;  • birth;  • the newborn baby; and  • feeding the newborn baby.
Unit 2: The Development of the Child (0–5 Years)	You will study:  • dietary needs of the child (0–5 years);  • child health and education; and  • development of the child:  - social development;  - physical development;  - intellectual development;  - communication development; and  - emotional development.
Unit 3: Investigation Task	<ul> <li>You will carry out research based on a given title.</li> <li>You will plan and carry out activities to produce an outcome.</li> <li>You will evaluate all aspects of the task.</li> <li>The task is split into five parts and you will have word limits to follow.</li> </ul>



### **HOW WILL I BE ASSESSED?**

## CROSS-CURRICULAR SKILLS AT KEY STAGE 4 COMMUNICATION, USING MATHEMATICS AND USING ICT

You will have opportunities to develop these skills in a variety of ways, for example:

- discussing the importance of immunisation;
- responding to exam questions;
- evaluating and debating the feeding options for a baby;
- interpreting information on food labels;
- recording bathwater temperature and body temperature;
- calculating estimated delivery date;
- understanding centile charts; and
- researching and accessing information online for the controlled assessment task.
